Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 10, 2023, placed the rating(s) of B. S. Enterprise (BSE) under the 'issuer non-cooperating' category as BSE had failed to provide information for monitoring of the rating. BSE continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 25, 2024, June 04, 2024, June 14, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Howrah (West Bengal) based, B. S. Enterprise (BSE) was constituted as a partnership firm on June 10, 2011. The firm is an associate concern of Gujral Group of companies. The group is promoted by Mr. Bhupinder Singh Gujral and engaged in transportation of LPG tankers for the major oil companies such as Bharat Petroleum Corporation Limited (BPCL), Ind ian Oil Corporation Limited (IOCL) and Hindustan Petroleum Corporation Limited (HPCL) and hotel and restaurant business. The group is having 975 LPG tankers and the loading point is Haldia, West Bengal. Currently BSE is managed by three partners namely, Mr. Bhupinder Singh Gujral, Mrs. Tejinder Kaur Gujral and Mr. Surojit Biswas. Since its inception, the firm is engaged in transportation of LPG tankers. The firm participates in tenders floated by various oil companies and executes orders mainly f or BPCL, IOCL and HPCL. Currently the firm has works orders from BPCL, IOCL and HPCL for transportation of bulk LPG by road for a period of three and a half years ended in April 2022.
