Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated July 04, 2023, placed the rating(s) of Shri Gautam Garments Private Limited (SGGPL) under the 'issuer non-cooperating' category as SGGPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGGPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 19, 2024, May 29, 2024 and June 08, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
