Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated July 21, 2023, placed the rating(s) of Ram Raghu Healthcare Private Limited (RRHPL) under the 'issuer non-cooperating' category as RRHPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RRHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 05, 2024, June 15, 2024 and June 25, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
