### Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated July 14, 2023, placed the rating(s) of India Dye Chem (IDC) under the 'issuer non-cooperating' category as IDC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. IDC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 29, 2024, June 08, 2024 and June 18, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
