### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated June 28, 2023, placed the rating(s) of Tuscan Agrow (TA) under the 'issuer non-cooperating' category as TA had failed to provide information for monitoring of the rating. TA continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 13, 2024, May 23, 2024, June 02, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
