Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated June 15, 2023, placed the rating(s) of Suresh Kumar & Sons Trading Private Limited (SKSTPL) under the 'issuer non-cooperating' category as SKSTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SKSTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 30, 2024, May 10, 2024 and May 20, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
