Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 04, 2023, placed the rating(s) of Sai Overseas (SO) under the 'issuer non-cooperating' category as SO had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SO continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 19, 2024, June 29, 2024 and July 09, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sai Overseas (SO) is a partnership firm established in March, 2016 by Mr. Rajbir Singh, Siddharth Jaglan and Mrs Kusum Jaglan. The firm commenced operations in December, 2016 with partial completion of project. The project got fully completed in November 2017. SO is engaged in the manufacturing of textile products (mainly home furnishing products) such as carpets, floor rugs, bathmats and towels etc at its manufacturing facility located at Karnal, Haryana.
