Rationale and key rating drivers

Cold Storage Private Limited (SMCSPL) under the 'issuer non-cooperating' category as SMCSPL had failed to provide information for monitoring of the rating. SMCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 06, 2024, May 16, 2024, May 26, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
