Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 23, 2023, placed the rating(s) of Narwal Hatcheries (NH) under the 'issuer non-cooperating' category as NH had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NH continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated July 08, 2024, July 18, 2024 and July 28, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
