## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 11, 2023, placed the rating(s) of Tirupati Fibers (TF) under the 'issuer non-cooperating' category as TF had failed to provide information for monitoring of the rating as agreed to in its rating agreement. TF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 26, 2024, July 06, 2024, July 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

## **About the Firm**

TF was formed as a partnership concern in 2003 by Mr Vijay Om Prakash Goyal, Mrs Neha Vijay Goyal and Mrs Radha Govind Goyal and share profit & loss equally. TF is engaged in the business of cotton ginning and pressing. The manufacturing unit of the firm is located at Jalna (Maharashtra). It procures raw cotton directly from farmers and local mandis.

**Status of non-cooperation with previous CRA:** Brickwork has continued the ratings assigned to the bank facilities of TF to 'Issuer Not Cooperating' category vide press release dated June 06, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.
