Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 13, 2023, placed the rating(s) of K. S. Cot Fiber Private Limited (KSCFPL) under the 'issuer non-cooperating' category as KSCFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KSCFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 28, 2024, June 07, 2024, June 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

KSCFPL is engaged into the business of cotton ginning and pr essing. KSCFPL deals in 'Shankar 6' type of cotton which is being sourced through local farmers from Madhya Pradesh and Maharashtra. KSCFPL operates from its sole manufacturing plant located at Sendhwa (Madhya Pradesh) which has an installed capacity of 18 ,900 Metric Tonnes Per Annum (MTPA) as on March 31, 2018.
