### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 14, 2023, placed the rating(s) of Gujral Roadwaays Private Limited (GRPL) under the 'issuer non-cooperating' category as GRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 29, 2024, June 08, 2024, June 18, 2024, among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Howrah (West Bengal) based, Gujral Roadwaays Private Limited (GRPL) was incorporated as a private limited company on February 05, 1993. The company is an associate concern of Gujral Group of companies. The group is promoted by Mr. Bhupinder Singh Gujral and engaged in transportation of LPG tankers for the major oil companies such as Bharat Petroleum Corporation Limited (BPCL), Indian Oil Corporation Limited (IOCL) and Hindustan Petroleum Corporation Limited (HPCL) and hotel and restaurant business. The group is having 975 LPG tankers and the loading point is Haldia, West Bengal.

**Status of non-cooperation with previous CRA:** India Ratings has continued the rating assigned to the bank facilities of GRPL into Issuer Not Cooperating category vide press release dated October 26, 2023 on account of its inability to carry out a review in the absence of the requisite information from the company.
