Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 20, 2023, placed the rating(s) of Jugendra Singh and Co (JSC) under the 'issuer non-cooperating' category as JSC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JSC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 05, 2024, August 15, 2024 and August 25, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Etah, Uttar Pradesh based Jugendra Singh and Co (JSC) was established in the year 1995 as a partnership firm. The current partners of the firm are namely; Mrs. Dhoopkali, Mrs. Ram Murti Devi, Mrs. Rekha Yadav, Mrs. Rajbala, Mrs. Amita Yadav and Mrs. Rashmi Yadav. The firm is "Class A" contractor and is engaged in civil construction works such as construction of roads, canals, RCC boundary walls, limited height subways, etc. and its related development & maintenance works mainly for government departments like Public Works Department, Uttar Pradesh, North Central Railways (NCR), North Eastern Railways (NER) and other local government bodies.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of JSC into Issuer Not Cooperating category vide press release dated May 20, 2024 on account of its inability to carry out a review in the absence of requisite information.
