Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 07, 2023, placed the rating(s) of SH TECH PARK Developers Private Limited (SHTP) under the 'issuer non-cooperating' category as SHTP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SHTP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 09, 2024, July 15, 2024 and August 01, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
