Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 22, 2023, placed the rating(s) of Shri Guru Gorakh Nath Rice Mill (SGGNRM) under the 'issuer non-cooperating' category as SGGNRM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGGNRM continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated July 07, 2024, July 17, 2024 and July 27, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
