Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 10, 2023, placed the rating(s) of Ulka Sea Foods Private Limited (USFPL) under the 'issuer non-cooperating' category as USFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. USFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 25, 2024, July 05, 2024 and July 15, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Incorporated in 2003, Ulka Sea Foods Private Limited (USFPL) was promoted by Rohakale family. USFPL is engaged in surimi fish production & processing of the seafood (primarily fish). USFPL primarily exports to Russia, Europe and other south-east ASIAN countries. USFPL has three manufacturing facilities (near Mumbai) which are approved by Hazard Analysis Critical Control Point (HACCP) and are also certified by European Union (EU). USFPL has a plant located at Taloja, MIDC.
