Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 14, 2023, placed the rating(s) of Vishal Wheelers Private Limited (VWPL) under the 'issuer non-cooperating' category as VWPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VWPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 29, 2024, June 08, 2024 and June 18, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Uttar Pradesh based, VWPL was incorporated in 2007 by Mr Amit Singh and Mr Vishal Singh. The company operates its business through its two divisions. It operates an authorized service centre of Maruti Suzuki India Ltd in Unnao (Uttar Pradesh).

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of VWPL into Issuer Not Cooperating category vide press release dated October 26, 2023 on account of its inability to carry out a review in the absence of requisite information.
