### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 31, 2023, placed the rating(s) of Columbus Overseas LLP (COL) under the 'issuer non-cooperating' category as COL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. COL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 15, 2024, June 25, 2024 and July 05, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
