Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 04, 2023, placed the rating(s) of Infinity Infratech (II) under the 'issuer non-cooperating' category as II had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. II continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 20, 2024, July 30, 2024, August 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Vapi-based (Gujarat), II was established by the proprietor, Mr Pratik Desai in 2010. The firm is engaged mainly in stone crushing activity and manufacturing of RCC (Reinforced Cement Concrete) Hume pipes and service tenders of government in civil projects. The proprietor owns a quarry from which stone is extracted and then extracted material is crushed and transformed in the form of various stones and artificial crushed sand. II owns two plants for stone crushing in Karajgam, located near Vapi (Gujarat). The major customers of II are located in Gujarat, Maharashtra and Dadra & Nagar Haveli
