## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 21, 2023, placed the rating(s) of Sai Enterprises (Vadodara) (SE) under the 'issuer non-cooperating' category as SE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 06, 2024, July 16, 2024, July 26, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sai Enterprises (SE) was established as a partnership firm during October 2011 in Vadodara, Gujarat. Subsequently the firm has opened its administrative office in Chennai and one branch office in Kolkata. SE is a relatively small sized firm engaged in shot hole drilling and onshore seismic service for oil exploration companies like Oil & Natural Gas Corporation Limited (ONGC), GEO API Solutions Pvt Ltd, Global Ecologistic Pvt Ltd, Alphageo (India) Ltd etc. The day to day operations are looked after by Mrs. Purnima Paul, partner, along with other partner Mrs Mamta Paul and a team of experienced personnel.
