Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 22, 2023, placed the rating(s) of Radhe Cotton Company (RCC) under the 'issuer non-cooperating' category as RCC had failed to provide information for monitoring of the rating. RCC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated July 07, 2024, July 17, 2024, July 27, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The partners of RCC include mainly Mr Rameshbhai Khakhriya, Manubhai Khakhriya and Dhirajbhai Jivabhai Khakhriya. The firm is engaged into the activity of cotton ginning, bailing and cleaning of cotton. The products of RCC include cotton seeds, cottonseeds oil cake and cotton wash oil.
