Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 25, 2023, placed the rating(s) of Paras Commercial Corporation (PCC) under the 'issuer non-cooperating' category as PCC had failed to provide information for monitoring of the rating. PCC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 09, 2024, June 19, 2024, June 29, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Paras Commercial Corporation (PCC), a partnership entity was incorporated in 1988 by Mr. Sanjay N. Mehta, Mr. Divyesh H. Mehta, Mr. Chetan H. Mehta and Mr. Rakesh H. Mehta. PCC is associated with M/S. Tata Chemicals LTD. (TCL) for entire range of products which includes salt, dal and pulses and with M/S. Tata Global Beverages LTD (TGBL) for tea as a super stockist for the last 30 years and also responsible for marketing and distribution of FMCG products across Odisha. Besides this, PCC is also a registered distributor of Creamy Foods Ltd (CFL) for Ghee and milk powder and of Ganesh Grains Ltd. for the entire range of wheat products. PCC is also engaged as Clearing and Forwarding (C&F) agent on behalf of its clients.

Status of non-cooperation with previous CRA: India Ratings has continued the rating assigned to the bank facilities of PCC into ISSUER NOT COOPERATING category vide press release dated September 12, 2023 on account of its inability to carry out a review in the absence of requisite information from the firm.

CRISIL has continued the rating assigned to the bank facilities of PCC into ISSUER NOT COOPERATING category vide press release dated November 13, 2023 on account of its inability to carry out a review in the absence of requisite information from the firm.
