Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 07, 2023, placed the rating(s) of Sk Samir Ali (SSA) under the 'issuer non-cooperating' category as SSA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 23, 2024, August 02, 2024, August 12, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sk. Samir Ali (Proprietor) has more than a decade of experience in civil construction industry, he looks after the day to day operations of the entity along with other technical and non-technical professionals who are having long experience in this industry.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SSA into ISSUER NOT COOPERATING category vide press release dated March 08, 2024 on account of its inability to carry out a review in the absence of requisite information from the firm.
