### **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated July 27, 2023, placed the rating(s) of Brightstar Healthcare Private Limited (BHPL) under the 'issuer non-cooperating' category as BHPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 11, 2024, June 21, 2024, July 01, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Moradabad, Uttar Pradesh based Brightstar Healthcare Private Limited (BHPL) is a private limited company and was incorporated in November, 2012. BHPL is setting up a 300-bed multi-specialty hospital in new Moradabad, Uttar Pradesh. The hospital would provide healthcare services in cardiology and cardiac surgery, nephrology, neurology, neurosurgery, anaesthesiology & critical care, orthopaedics, urology, among others.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of BHPL into Issuer Not Cooperating category vide press release dated July 08, 2024 on account of its inability to carry out a review in the absence of requisite information.
