CARE Ratings Ltd. had, vide its press release dated August 17, 2023, placed the rating(s) of Archana Flour Mill (AFM) under the 'issuer non-cooperating' category as AFM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AFM continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated July 02, 2024, July 12, 2024 and July 22, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
