## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 08, 2023, placed the rating(s) of Datamini Technologies (india) Limited (DTL) under the 'issuer non-cooperating' category as DTL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DTL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 23, 2024, July 03, 2024 and July 13, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### **About the company**

Incorporated in 1991, Datamini Technologies (India) Limited (DTL) is ISO 9001:2001 and ISO 14001 certified company engaged in trading of laptops and computer peripherals of international brands such as HP, Dell, D-Link, Panduit, Cisco, Systemax, Smartlink, Digisol. DTL is also engaged in assembling of computer desktops and tablets under 'Datamini' brand, annual maintenance services accounts for the rest. DTL has registered office and main service center located in Mumbai, 7 branch offices (located in Bengaluru, New Delhi, Hyderabad, Kolkata, Karad, Pune and Surat), a manufacturing facility and warehouse located in Bhiwandi, and 70 support service centers located in pan-India through authorized service partners.

**Status of non-cooperation with previous CRA**: Brickwork has continued the rating assigned to the bank facilities of DTL into Issuer Not Cooperating category vide press release dated June 13, 2024 on account of its inability to carry out a review in the absence of requisite information.
