## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated August 04, 2023, placed the rating(s) of Sinnar Taluka Vibhagiya Sahakari Dudh Utpadak And Prakriya Sangh Limited (STVSDUPSL) under the 'issuer non-cooperating' category as STVSDUPSL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. STVSDUPSL continues to be noncooperative despite repeated requests for submission of information through e-mails dated June 19, 2024, June 29, 2024 and July 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
