Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 09, 2023, placed the rating(s) of Sangotra Fashions Private Limited (SFPL) under the 'issuer non-cooperating' category as SFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 24, 2024, July 04, 2024 and July 14, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SFPL have been revised on account of non-availability of requisite information.

Sangotra Fashions Private Limited (SFPL) was incorporated in the year 2010 as a private limited company by. SFPL is engaged in manufacturing and exporting of readymade garments for men, women and children's wear like capris, full pants, skirts, tops, shirts, trousers etc. Further SFPL manufacturing unit is located at Bhandup, Mumbai.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of SFPL into Issuer Not Cooperating category vide press release dated May 31, 2024 on account of its inability to carry out a review in the absence of requisite information.

India Ratings has continued the rating assigned to the bank facilities of SFPL into Issuer Not Cooperating category vide press release dated July 14, 2024 on account of its inability to carry out a review in the absence of requisite information.
