Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated July 24, 2023, placed the rating(s) of Indesys Equipments Private Limited (IEPL) under the 'issuer non-cooperating' category as IEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. IEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 08, 2024, June 18, 2024 and June 28, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Prior to 2012, the company was known as "Intel Design Systems India Private Limited" (IDSPL). IEPL is engaged in the trading of CBRN (chemical, biological, radiological and nuclear) protection systems and manufacturing of CBRN (chemical and nuclear) protection systems.
