CARE Ratings Ltd. had, vide its press release dated September 05, 2023, placed the rating(s) of Protima Alu Company (PAC) under the 'issuer non-cooperating' category as PAC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PAC continues to be non-cooperative despite repeated requests for submission of information through emails dated July 21, 2024, July 31, 2024, August 10, 2024, among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
