# **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated August 02, 2023, placed the rating(s) of Bhavani Enterprises\_Hubli (BE) under the 'issuer non-cooperating' category as BE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 17, 2024, June 27, 2024, July 07, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
