GE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 23, 2024, August 02, 2024 and August 12, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
