Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 11, 2023, placed the rating(s) of Shiv Parvati Solar Energy (SPSE) under the 'issuer non-cooperating' category as SPSE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPSE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 26, 2024, July 06, 2024, July 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The company has set-up a 1 MW solar photovoltaic (PV) power plant located in Jambagi K D village, Bagalkot district of Karnataka. The project achieved commercial operational from February, 2017.
