## **Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated August 03, 2023, placed the rating(s) of Tirupati Trading Corporation (TTC) under the 'issuer non-cooperating' category as TTC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TTC continues to be non-cooperative despite repeated requests for submission of information through emails, phone calls and a letter/email dated June 18, 2024, June 28, 2024 and July 08, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
