## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 04, 2023, placed the rating(s) of Om Shivashakthi Poultry Breeders (OSPB) under the 'issuer non-cooperating' category as OSPB had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OSPB continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 19, 2024, June 29, 2024, July 09, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Om Shivashakthi Poultry Breeders (OSPB) was established in the year 2004 and promoted by Mr. Ramaswamy (Managing Partner), Mrs. Girijamma Ramasamy (Partner), Mrs. K.R. Vachana (partner) and Mr. K.R.Ravindra (Partner). The firm is engaged in farming of egg, laying poultry birds (chickens) and trading of eggs, cull birds and their Manure. The firm sells its products like eggs and cull birds in Kerala to retailers through own sales personnel and through some dealers. The firm mainly buys chicks (small chickens) from Kerala. The firm purchases raw materials for feeding of birds like rice broken, maize, sun flower oil cake, shell grit, minerals and soya from local traders.
