Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 05, 2023, placed the rating(s) of Atmaram Auto Enterprises (AAE) under the 'issuer non-cooperating' category as AAE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AAE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 21, 2024, July 31, 2024 and August 10, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Atmaram Auto Enterprises (AAE) is a partnership firm established in April, 1985. The firm is currently managed by Mr. Ramesh Agarwal. AAE is an authorized dealer of "Hero Motocorp Limited" and "Mahindra & Mahindra Limited" vehicles. The firm operates through its 3S (Sales, spare & services) facility and is engaged in the sale of two wheelers, passenger vehicles, light commercial vehicles and its spare parts. The firm operates through its four showrooms and three workshops; five are located at Agra (Uttar Pradesh) and two in Mathura (Uttar Pradesh)

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of AAE into Issuer Not Cooperating category vide press release dated August 30, 2023 on account of its inability to carry out a review in the absence of requisite information.
