Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 11, 2023, placed the rating(s) of Maa Kamakshya Enterprise (MKE) under the 'issuer non-cooperating' category as MKE had failed to provide information for monitoring of the rating. MKE continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 26, 2024, July 06, 2024, July 16, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Maa Kamakshya Enterprise (MKE) was established in October 2010 by Mrs. Poonam Singh based out of Darjeeling, West Bengal. Since its inception, the firm has been engaged in trading of FMCG products and the product portfolio of the firm includes cigarettes, beverage, food, snacks, skin & personal care products. The entity has taken distributorship of reputed principals like ITC Limited and Kellogg India Private Limited since its inception. Mrs. Poonam Singh (Proprietor) who has around 11 years of experience in similar line of business looks after the overall operations of the entity. Further, she is supported by her husband Mr. Manoj Singh and along with a team of experienced salespersons who have rich experience in the same line of business.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of MKE into ISSUER NOT COOPERATING category vide press release dated May 16, 2024 on account of its inability to carry out a review in the absence of requisite information from the firm.
