Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 18, 2023, placed the rating(s) of Ratna Cottex (RC) under the 'issuer non-cooperating' category as RC had failed to provide information for monitoring of the rating. RC continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated July 03, 2024, July 13, 2024, July 23, 2024.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Morbi based Ratna Cottex (RC) was established in May, 2015 as a partnership firm owned and managed by Mr. Harshad Jasmatbhai Ghodasara, Mr. Danjuma Jasmatbhai Ghodasara and Mr. Jasmatbhai Valjibhai Ghodasara. The firm is currently engaged in cotton ginning and pressing for BT variety of cotton with short and medium staple fibre, having sole manufacturing facility located in Morbi, with an annual installed capacity of 5,488.56 Metric Tons of cotton bales and 10977.12 Metric Tons of cotton seeds as on March 31, 2017. RC commenced its operations from December, 2015 with 24 ginning machines.
