Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 12, 2023, placed the rating(s) of Koyili Hospital (KH) under the 'issuer non-cooperating' category as KH had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KH continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 28, 2024, August 07, 2024, August 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
