## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated August 18, 2023, placed the rating(s) of Smart Visions (SV) under the 'issuer non-cooperating' category as SV had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SV continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 03, 2024, July 13, 2024, July 23, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Smart Visions (SV) is a Bangalore based firm engaged in commercial offset printing activities. SV was promoted by Mr. Vishwanath Bharat as a proprietorship concern in the year 2000. SV is engaged majorly in printing orders for posters, banners, danglers, magazines etc. SV has installed seven offset printing machines with installed capacity of 100000 posters per machine per day. The capacity utilization of the machines is based on the orders the firm receives it from its customers.
