Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 15, 2023, placed the rating(s) of Om Agro (OA) under the 'issuer non-cooperating' category as OA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 31, 2024, August 10, 2024, August 20, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of OA have been revised due to non-availability of requisite information.

Presently the firm has sortex plant with total capacity of 200MT average rice sortexing capacity per day.
