Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 25, 2023, placed the rating(s) of Orange Automotive Private Limited (OAPL) under the 'issuer non-cooperating' category as OAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 10, 2024, August 20, 2024 and August 30, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

OAPL is an authorized automobile dealer (PV vehicle) for Hyundai cars since October 2013 and Bajaj two wheelers from January, 2018. The company prior used to deal with Yamaha bikes. The company also undertakes the sale of spare parts, accessories and lubricants along with servicing facility. The company is member of Federation of Auto Dealers Association (FADA). Moreover, apart from operations in automobile industry, OAPL is also engaged in trading of computers and electronics. OAPL operates two different showrooms for sale of Hyundai cars and Bajaj bikes, both are located in Amreli, Gujarat.
