Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 12, 2023, placed the rating(s) of Veera Associates (VA) under the 'issuer non-cooperating' category as VA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 28, 2024, August 07, 2024, August 17, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Firm

Veera Associates (VA) was initially started as a proprietary concern in 2005 with the name of Sarika Cotton Traders and later on the constitution was changed to partnership firm and subsequently the firm was renamed to current nomenclature. The firm is being promoted by Mr. Kuppam Venkata Prasad who has more than 25 years of experience in textile industry. The firm is engaged in manufacturing and trading of polyester viscose yarn and cotton yarn. The manufacturing facility is located at Adapazarı, Guntur District, and Andhra Pradesh with a total installed capacity of 1630 MTPA with total spindles of 8160.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of VA to the 'issuer not-cooperating' category vide press release dated September 22, 2023 on account of its inability to carryout review in the absence of requisite information from the firm.
