Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 17, 2023, placed the rating(s) of Arihant Prime Developers Private Limited (APDPL) under the 'issuer non-cooperating' category as APDPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. APDPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 01, 2024, September 11, 2024 and September 21, 2024 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Jaipur (Rajasthan) based, APDPL was incorporated as a private limited company in June, 2011 by Mr. Vimal Nahata and Mr. Tarun Nahata, later joined by Mr. Arun Nahata, Mr. Varun Nahata and Mrs. Durga Devi Sharma as directors. APDPL belongs to Arihant Prime Builders which has established track record of more than a decade into same line of business.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of APDPL into Issuer Not Cooperating category vide press release dated May 15, 2024 on account of its inability to carry out a review in the absence of requisite information.
