Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 12, 2023, placed the rating(s) of Happy Acoustics Private Limited (HAPL) under the 'issuer non-cooperating' category as HAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 27, 2024, September 06, 2024 and September 16, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

HAPL was incorporated on March 16, 2012 by Mr Amarjit Singh Kalra and his wife, Ms Surinder Kaur Kalra. The company is involved in the manufacturing and assembling of public address (PA) systems and components, including loud speakers, amplifiers, microphones, and woofers, and related electronic and electrical equipment. The company commenced operations in September, 2012 and its manufacturing facility is located in Delhi.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of HAPL into Issuer Not Cooperating category vide press release dated February 14, 2024 on account of its inability to carry out a review in the absence of requisite information.
