Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 06, 2023, placed the rating(s) of Jaya Guru Saw Mill (JGSM) under the 'issuer non-cooperating' category as JGSM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JGSM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 22, 2024, August 01, 2024, August 11, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Jaya Guru Saw Mill (JGSM) was established in 1990 as a proprietorship firm by Mr. R. Jeyabal (Proprietor). The firm is engaged in trading (wholesale and retail) of wood and teak products from past 30 years. The firm imports majority of the timber wood from the suppliers located in the international markets like Singapore, Dubai and France. The firm sells the products to customers located in Salem, Chennai, and Kerala.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of JGSM into Issuer Not Cooperating category vide press release dated May 17, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.
