Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated September 01, 2023, placed the rating(s) of Jay Jalaram Enterprise (JJE) under the 'issuer non-cooperating' category as JJE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JJE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 17, 2024, July 27, 2024 and August 06, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

M/s. Jay Jalaram Enterprise (JJE) is a proprietorship firm established by Mr Kamlesh Thakkar in 2008. The firm is an authorized wholesale distributor of Micromax Informatics Limited (MIL) for Ahmedabad region since January 2014.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of JJE into Issuer Not Cooperating category vide press release dated August 30, 2024 on account of its inability to carry out a review in the absence of requisite information.
