Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated September 25, 2023, placed the rating(s) of Shaktiman Bio Agro Industries Private Limited (SBAIPL) under the 'issuer non-cooperating' category as SBAIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBAIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated August 10, 2024, August 20, 2024 and August 30, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
