Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated August 09, 2023, placed the rating(s) of India Cartons (IC) under the 'issuer non-cooperating' category as IC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. IC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 24, 2024, July 04, 2024, July 14, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

India Cartons (IC) was established by Mr. C. Madanraj and his son, Mr. M. Naresh Kumar on April 08, 2010 as a partnership concern in Ambur, Tamil Nadu. The firm is engaged in manufacturing of packaging material for the footwear industry. The main products manufactured by IC include cartons, corrugated cartons and rigid boxes. The entity sells its finished products to customers located in Tamil Nadu, Karnataka and Indore. The major raw material being duplex boards are procured from suppliers in Tamil Nadu and China for finer quality. The manufacturing unit is also located in Ambur, Tamil Nadu.
