Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated October 17, 2023, placed the rating(s) of Shankheshwar Enterprises (SE) under the 'issuer non-cooperating' category as SE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated September 01, 2024, September 11, 2024 and September 21, 2024 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Shankheshwar Enterprises (SE), based in Ludhiana, Punjab was established in 2000 as a partnership firm with Mr. Sudhir Jain, Mr. Harish Jain and Mr. Dhimant Jain as partners. The firm is engaged in manufacturing of knitted cloth and fabrication i.e. embroidery, printing etc. as its facility located in Ludhiana, Punjab.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of SE into Issuer Not Cooperating category vide press release dated March 27, 2024 on account of its inability to carry out a review in the absence of requisite information.
